



# Digitalization in IsDB's Realigned Strategy (2023-2025)


- ICT and Digitalization is one of the key focus areas under Pillar 1 of IsDB's Realigned Strategy (2023-2025).
- IsDB's Regional Cooperation and Integration (RCI) operations contribute to IsDB's strategic cross-cutting pillar on capacity development as well as Pillar 1 through crossborder transport, energy and ICT connectivity projects.





# ICT Connectivity and Investment Climate in IsDB's RCI Policy

- Vision: IsDB MCs coexist harmoniously and achieve sustainable and interdependent growth through mutual cooperation.
- Mission: Working as "One IsDB Group" in cooperation with public and private sector partners to bring together member countries, regional cooperation organizations and communities to achieve inclusive growth through joint actions.
- Enhanced cross-border ICT connectivity (both physical and soft) and improved investment climate are among the main pillars of IsDB's RCI Policy.





### Stages of Building a Robust Digital FDI Ecosystem

Improving the investment climate (regulatory and non-regulatory measures)

Enhancing ICT infrastructure and connectivity (regional level) Transitioning to digital economy (local talents and cross-border <u>standardization</u>)




# The Role of Partnerships in Enhancing Digital FDI Ecosystems

- ✓ Basic ICT Infrastructure (governments and the private sector)
  - Building a conducive environment for ICT infrastructure investments and utilizing PPP models to expand digital infrastructure networks
- Customizing education strategies to enhance digital skills of people and businesses (governments and the private sector)
- ✓ Cross-cutting priorities such as gender (civil society)
- ✓ Regulatory harmonization (intergovernmental coordination)
  - Cross-border data flows, cybersecurity, trade and investment facilitation


#### **ITAP: Objectives & Rationale**

#### ITAP's main objective is

to offer **technical assistance** and **capacity building services** to IsDB MCs' *investment promotion agencies* 

to support their efforts in attracting **domestic** and **foreign direct investment** 

- Greater recognition of the role of the private sector and foreign direct investment in sustainable socio-economic development of a country
- The need for improving the investment climate and capacity to attract FDI by IsDB MCs
- Lack of investment promotion capacity
- The need for articulating competitive sectors and projects
- Lack of information sources and databases





#### IsDB's Ongoing Work to Support Digitalization

- ✓ ICT Connectivity (telecommunication network upgrade project in Turkmenistan)
- Regional-level digital transformation programs (Digital CAREC, Digital Economy in the West African Economic and Monetary Union area)
- Cross-border electronic data exchange between customs and trade facilitation agencies (e-CMR project in the ECO region)
- ✓ Supporting the use of digital trade facilitation tools (such as e-TIR and e-CMR).
- ✓ Utilizing digital tools to inform project development (GIS project with UNECE and ECO)
- ✓ Synergizing ITAP, Reverse Linkage, and Science, Technology and Innovation (STI) activities to ensure a holistic approach
- $\checkmark$  A new regional connectivity initiative with development partners in Central Asia
